THEME

PROGRAM PROPOSALS

Any member of C.G.C.A. may propose a fully organized program. Time of each program will generally be 1¼ to 1½ hours. Proposals should be submitted before February 1, 1969, and should include (1) Title of program, (2) Name and mailing address of each participant, (3) A Statement of approximately 100 words describing the program, (4) Preferred sub-theme (above) for program, (5) Special arrangements.
